MINIMUM BUSINESS TAX	\$200.00
BUILDING PERMITS	
Residential:	
New dwelling construction	\$50.00 – valid for one year
Garages, Sheds, etc.	\$25.00 – valid for one year

General Repairs/Renovation \$20.00 – valid for one year
(Exceeding \$1000.00 in value)

Commercial:

New construction & Extensions \$0.5/square foot/minimum \$50.00
General Repairs/Renovations \$25.00 – valid six months

OTHER PERMITS AND FEES:

Building Demolition: \$110.00 deposit (valid 90 days)
(100.00 refund when site is cleared up)
New Water Connections Actual costs + \$25.00 inspection fee
Tax Certificate \$50.00
Water turn on /off after hours \$50.00 (except in emergency)
Water turn on if shut off for
areas of taxes \$50.00 + all outstanding taxes
Fire Protection Fees \$60.00/unit/year
Backhoe Rate \$ 50.00/ hour
Loader Rate \$ 75.00 / hr
Dump Truck Rate \$ 50.00/ hr

Pursuant to the Municipalities Act, the deadline for exemption from poll tax (based on previous year's gross income) is June 30, 2022. No exemptions granted after this date.
